## GENERAL SECRETARY'S RANTS AND RAVES

Welcome back to the new season. The first of these for the season with a few rules and instructions that **WILL HAPPEN THIS SEASON.**

1. Monthly invoices **WILL WITHOUT FAIL** be settled on time by the due date. The Financial Secretary would appreciate **ALL CLUBS** paying by cheque posted to him on receipt of the invoice. Of course we know this will not happen so be warned "Any club not settling their invoice by the close of the League Council meeting (Final payment date) **WILL** be suspended immediately that night without exception." Penalties of rule 25h will be imposed £ 20.00 fine plus cancellation of the following Sunday's fixture which will be awarded to the opponents. Club will also be charged full pitch fee. This will happen even if the debt is settled the next day so be warned.
2. Match cards **WILL BE SENT** to the Registration Secretary by the Wednesday following the date of the match. If a card is not received on time the Registration Secretary will contact the home club immediately to inform them. As in previous seasons photocopies of a card will be accepted as proof. Once a club has been informed of a missing card they will have until the following Sunday to provide the original or a copy to the Registration Secretary. If this does not happen rule 28f will be applied and published on the circular and there will be no appeal or rescinding of the offence.
3. **ALL** results will be phoned in on time on match days without fail.
4. **ALL** correspondence and telephone messages **MUST** be answered immediately and all instructions carried out in the required time without fail. Failure to do so may result in more serious action being taken.
5. **ALL** London F.A. correspondence must be dealt with immediately and any debts cleared. Failure to do so will result in suspension from competition and penalties of rule 25h applied to any fixtures arranged.
6. **ALL CLUBS** will be represented at League Council meetings

We will have compliance from all clubs this season.

Already there are some clubs who cannot comply with instructions

**Apollo, Enfield Eagles, Port Louis, Travellers United and Village United** have not given the General Secretary their LFA affiliation numbers despite reminders and are deemed not to be affiliated. **NO AFFILIATION = NO FIXTURES**

**Clavisque, Enfield Eagles, Enfield Lions, Goodwill, Green City, Hornsey Vale, Kingfisher, Port Louis, Santos Athletic and Sparta Futbol** must provide proof of Insurance by the 1st August 2011. Reminders have been given by Financial Secretary and General Secretary so there is no excuse. **NO INSURANCE = NO FIXTURES**
