GENERAL SECRETARY'S RANTS AND RAVES.

Respect your opponents, referees and those who provide football for you on Sundays. It has also been reported to us by the Council that some clubs are not vacating the dressing rooms by 1.00 pm in accordance with our hire agreement and not respecting the ground staff when they are asked to leave. This too must stop now or the Council may refuse to hire pitches to offending clubs which is their right to do. Easy solution to the problem. No pitch then no football so start complying.
