GENERAL SECRETARY'S RANTS AND REMINDERS.

Firstly a reminder about the duties of the Management Committee as some of you still cannot work it out on your own.

Mr Ken Martin deals with Finance which means monetary matters. Mr Garry Brooks deals with Registration matters which is player registration and match cards. Mr David Lyons deals with fixtures. Mr Carl Gomes would normally deal with referee issues but as stated above Mr Lyons will deal with this until he is fully recovered. Anything that does not fall into the above is dealt with by the General Secretary Mr Lyons. Please ensure that you contact the correct officer. Ken Martin knows nothing about fixtures and Dave Lyons knows very little about finance.

Another issue that seems to cause confusion is fixture publication. Fixtures are published 2 weeks in advance and then re-published a week later with referee names. Fixtures do not change in the week between the two dates unless clubs are informed.

At present the postal stage coach has one or two wheels missing and circulars are being delayed. If you have not received it by the Thursday please contact the General Secretary for information. Don't leave it until the last moment to find out your fixture. We are endeavouring to keep the website fully updated and are also going to experiment by emailing circulars to club secretaries with email addresses to solve the problems. If successful it could be implemented permanently saving the League money and the General Secretary a lot of time. Check your emails regularly and reply when asked so that we can judge the success rate.
